The legal voters of the Windham Northeast Union Elementary School District, consisting of the Towns of Athens, Grafton and Westminster, Vermont, are hereby warned to vote by Australian ballot at those places designated by the towns of those communities for voting, on or before 7 P.M. on March 2, 2021 and to act on the following articles:

ARTICLE 1

To elect by ballot, the following officers of the District from among its qualified voters, to serve a one-year term:

- Moderator
- Clerk
- Treasurer

ARTICLE 2

Shall the voters of the Windham Northeast Union Elementary School District appropriate the sum of \$6,954,684 (Six million, nine hundred fifty-four thousand, six hundred eighty-four dollars) which is the amount that the Board has determined to be necessary for the ensuing year? It is estimated that this proposed budget, if approved, will result in education spending estimated to be \$18,533 (Eighteen thousand, five hundred thirty-three dollars) per "equalized pupil" under the current state formula for calculating this figure. This projected spending per equalized pupil is 1.07% less than last year.

ARTICLE 3

To elect by ballot, the following Board members of the District, from among its qualified voters, for the terms stated below?

Reserved for residents of Athens, to be elected at large by the entire District;

-1 member for a two-year term beginning 2021.

Reserved for residents of Westminster, to be elected at large by the entire District:

-1 member for a two-year term beginning 2021.

Reserved for residents of Grafton, to be elected at large by the entire District:


-1 member for a two-year term beginning 2021.


