Article 1: Shall the voters of the Athens Grafton School District (WNUESD) approve the school board to expend \$1,822,000 (One Million, Eight Hundred Twenty-Two Thousand Dollars), which is the amount the school board has determined to be necessary for the ensuing fiscal year.

Article 2: Shall the voters of the Athens Grafton School District (WNUESD) apply the sum of \$250,000 (Two hundred fifty thousand dollars) from the Athens Grafton School District's fiscal years 2022 and 2023 surpluses of \$477,310 (Four Hundred Seventy-Seven Thousand Three Hundred and Ten Dollars) which are included in the 2023 FUND BALANCE of \$827,640 (Eight Hundred Twenty-Seven Thousand Six Hundred Forty Dollars) to reduce expenditures in the fiscal year 2025 in order to reduce taxes.

Article 3: Shall the voters of the Grafton Athens School District (WNUESD) apply the sum of \$142,310 (One Hundred Forty-Two Thousand Three Hundred and Ten Dollars) from the fiscal year 2023 FUND BALANCE to reduce expenditures in the fiscal year 2026 in order to reduce taxes.

Article 4: Shall the voters of the Athens Grafton School District (WNUESD) apply the sum of \$85,000 (Eighty-Five Thousand Dollars) from the fiscal year 2023 FUND BALANCE to a reserve to use for tuition expense and authorize the Board to expend said funds as needed

Article 5: Shall the voters approve an annual compensation to school directors in the amount of: Board Chair \$750, Board members \$600, District Treasurer \$200, District Clerk \$250, and additional stipend for members of the Supervisory Union Board \$250
